Saskatchewan Bleeding Disorders Program



Hemophilia Injury Recognition Tool (<u>HIRT?</u>) is now available for download

<u>HIRT?</u> was officially launched December 4th, 2014 in a joint media event between Winnipeg and Saskatoon. It is now available for download.

This app was developed following research with and feedback from young men age 18-35 with Mild Hemophilia. This research identified that young men with mild hemophilia often delay getting medical treatment because they cannot always determine the difference between 'mild' injuries and significant bleeds. The recently released CHS booklet "Identifying common joint & muscle bleeds" is included in the app to further assist with assessment.

This App will assist young men with mild hemophilia in self-management by:

- Helping them to identify signs and symptoms of a bleed Encouraging the use of first aid
- Reminding the young men to re-assess the injury (1 hour, 24 hours and 2 days) until the risk of re-bleed has passed
- Providing Hemophilia treatment center contact information so they can access medical attention if the symptoms worsen

It is free and available from the Apple Store and Google Play. The app is adaptable to all screens (e.g., smartphones and tablets).

Insurance and Medical Conditions—

Hi everyone- I just want to draw your attention to the useful new link on the Canadian Hemophilia Society website- under Support and Education, the last item in the dropdown menu is INSURANCE.

There are guides to Individual Insurance, Travel Insurance and Provincial Health Plans.

The Individual Insurance section has some excellent advice for considering a policy and some useful links to the OmbudServices for Life and Health Insurance (www.olhi.ca),

There is also information about the Medical Insurance Bureau, a non profit data sharing service where, if you have applied for insurance in the past 7 years, your data may be stored there and shared. You can request to check your information for accuracy. Do so by visiting www.mib.com and completing the request for information or contact the MIB at 416[597] 0590.

The Travel Insurance section reviews insurance by province and by the two most common travel insurance policies- Blue Cross and RBC Travel Insurance. There is a link to a helpful Guide to Travel Insurance, which lists questions that you should ask. Please note that information on travel health insurance can be obtained on the Web site of the OmbudService for Life & Health Insurance:

Hemophilia Saskatchewan "200 Club"

Purpose: To provide a stable, reliable, predictable, ongoing and adequate source for funding. If we can find at least 100 families, groups or individuals who will pledge a minimum of \$200 per year on an ongoing basis for the foreseeable future, Hemophilia Saskatchewan would be assured of a minimum income of \$20,000 per year.

The 200 Club is different from a one-time financial campaign, because it is ongoing, every year

for the foreseeable future.

The fund would be administered by the treasurer, who would issue receipts for income at year end. Note that the government allows a 43% tax credit for donations over \$200.

A commitment to the 200 Club is made on the understanding that if the contributors 'financial situation changes, the yearly commitment could be discontinued at any time.

The 200 Club is not meant to be an elite, exclusive club. It is a group of concerned committed people who want to see Hemophilia Saskatchewan become self-sufficient, not depending on any help from CHS.



Children's Wish

Children between the ages of 3 and 17, who have moderate to severe Hemophilia (or other severe bleeding disorders) are eligible to apply for consideration of a wish from the Children's Wish Foundation!

Wishes tend to fall under 3 categories- travel, an item, or a celebrity contact (which often involves travel). Examples have been trips to Disneyworld, home entertainment centers or computers, specific home renovation/decoration projects, contact with a sports or entertainment figure. The idea is that it be something meaningful and special for the child.

They have a One Child, One Wish policy, and will not grant a wish to a child who has previously received a wish from another wish granting agency. A child who has received a wish grant in the past, can apply for a subsequent wish in the event of a new high-risk life threatening illness.



You will need to sign consents for release of information. Your child's doctor or haematologist will be contacted to verify the medical condition. Shelley would then assist you in submitting the wish request, which is then referred to their national office for a decision. If the wish is granted, Shelley would assist you in planning how to fulfill the wish.

Bad jokes aside, just a reminder about income tax information related to health.

Medical Travel Expenses:

If you travel for medical care, there are also deductions to consider:

- * Round trips of over 40k (most direct route) can be claimed.
- * Mileage and parking, fares, cab, gas costs etc are included
- * For trips of over 80k, you can also claim meals and accommodation.

The claim must be reasonable and documented (SBDP post clinic letters would meet this requirement.)

You can claim over 12 months, not by tax year- this can be important in maximizing the claim because it is based on a percentage of a larger number.

The claim can be maximized by using one claimant, or it can be shared.

Remembering the Tainted Blood Tragedy: Commemoration 2014

Background

During the 80's, Canada's blood system was contaminated with HCV and HIV. Twenty thousand - 30,000 Canadians contracted hepatitis C; over 1200 Canadians contracted HIV which **at that time**, inevitably progressed to AIDS. (note: in 2014, with treatment adherence, people living with HIV can live an almost normal life span.) During the tainted blood tragedy, the hemophilia community was decimated. Described as the worst public health disaster in Canadian history, the tragedy was preventable.

Justice Horace Krever was appointed to head the Commission of Inquiry on the Blood System in Canada. The Krever Inquiry began in October 1993 with its Final Report released in November 1997. Justice Krever's number one recommendation was that all blood-injured Canadians receive compensation, and receive the compensation in a timely manner. For many Canadians, the legal sagas continue to this day.

For a greater appreciation of the cascading events (cavalier decisions, non-decisions, delays, destruction of key documents, importing plasma collected in US prisons, using up supply of contaminated product . . .), I recommend two books and a dvd which are available through the Saskatchewan library system:

Andre Picard The Gift of Death: Confronting Canada's Tainted blood Tragedy, 1998 Vic Parsons Bad Blood: the Tragedy of the Canadian Tainted Blood Scandal, 1995 Marilyn Ness (Director) Bad Blood: A Cautionary Tale (82 minutes; 2010)

The Canadian Hemophilia Society encourages each chapter to find its own ways to commemorate the tainted blood tragedy each year. Are you interested in planning, organizing and/or participating in future commemoration events? e.g. Commemoration 2017 will mark 20 years since the release of Krever's Final Report and there are two more commemorations between now and 2017. If so, speak with a board member; your interest would be warmly welcomed!

Seasonal Influenza Vaccine A few reminders for those Persons with Bleeding Disorders

It's that time of year again to decide if the Seasonal Influenza Vaccine is for you. The following is for your consideration in regards to the Seasonal Influenza Vaccine.

Influenza is a contagious viral disease of the respiratory system. It is spread by coughing, sneezing, or direct contact. Generally influenza may result in you being at home sick for a few days. However it can also result in hospitalization and even death especially in very young children, the elderly, and those with serious underlying health conditions.

Since 2011, the Saskatchewan Ministry of Health has made it possible that every Saskatchewan resident is eligible to receive the Seasonal Influenza vaccine free of charge.

There are special precautions to be aware of for those with bleeding disorders. Individuals with a bleeding disorder are at risk for developing a hematoma with the intramuscularly injection of the Seasonal Influenza Vaccine. To lessen the risk of developing a hematoma it is recommended that.

For those who are receiving regular prophylactic doses of factor concentrates, it is suggested that the vaccination should be scheduled shortly after a factor treatment when ever possible.

For all individuals with a bleeding disorder a 23-gauge or finer needle should be used for the vaccination.

Following the injection, firm pressure should be applied to the site for <u>at least 5 minutes</u>. The site <u>should not be</u> rubbed or massaged.

If these instructions are followed, a muscle bleed at the site of injection is very uncommon. However, if you notice swelling at the injection site, you should have it checked by the Hematologist or Nurse Coordinator from your Saskatchewan Bleeding Disorders Team.

Antibody protection usually begins within 2 weeks after the immunization in the majority of healthy individuals and can prevent illness in about 70% of these healthy people. (Information obtained from the Saskatchewan Ministry of Health 2011-2012 Seasonal Influenza Vaccine Fact Sheet and All about Hemophilia: A Guide for Families)


DONATING JUST GOT EASIER



Just a friendly reminder to contact the Saskatchewan Bleeding Disorders Program (SBDP) at least 2-4 weeks PRIOR to any scheduled surgeries, medical or dental procedures that may cause bleeding. This would ensure we had adequate time to make the required arrangements to control possible bleeding that may occur, as well as to educate the health care personnel that may be involved with your care/treatment. If enough notice isn't received your scheduled surgery, medical or dental procedure could be postponed or even canceled.
